Further, their classification level reflects that the potential to re-offend is low. This sex offender is currently under a period of probation supervision. This offender has notified the New York State Sex Offender Registry that he will be living in the location listed below. **HE IS NOT WANTED BY THE POLICE. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.**

The Guilderland Police Department has no legal authority to direct where a sex offender may or may not live. Unless court ordered restrictions exist, this offender is constitutionally free to live wherever he chooses. Sex offenders have always lived in our communities; but it wasn't until the passage of Megan's Law (Sex Offender Registration Act) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders is illegal. Further, such abuse could potentially end law enforcement's ability to do community notifications.

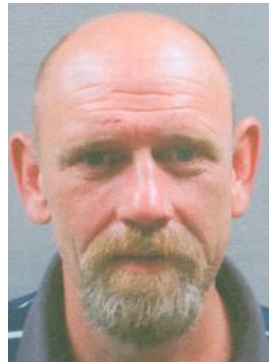
